(57) Abstract :

[036] The present invention discloses a voice-activated legal advisory system designed to provide real-time, hands-free legal assistance during emergency situations such as unlawful detentions, harassment, domestic violence, or roadside encounters. Leveraging advanced speech recognition, natural language processing, and context-aware detection through sensors like GPS and audio classifiers, the system delivers jurisdiction-specific legal guidance in response to verbal commands or automatically detected distress conditions. The invention includes secure, timestamped audio recording features for evidence preservation and enables encrypted communication with emergency contacts or legal entities. Deployable across smartphones, wearables, and vehicle systems, and operable in multilingual and offline modes, the invention bridges the gap between immediate legal need and access to counsel, empowering individuals to understand and assert their rights effectively during moments of vulnerability.
