TERMS & CONDITIONS OF NOTICE INVITING QUOTATIONS

1. Quotation should be for FREE DELIVERY, as applicable, at the University campus, unless otherwise agreed.
2. Prices quoted should be net and minimum period of validity of the quotation should be for one month from the closing date & should be free from CORRECTIONS.
3. Time of completion must be stated, which must be adhered to.
4. The University does not bind itself to accept the lowest or any tender or assign any reason for non-acceptance. It further reserves the right to accept any tender in part or in whole at its option.
5. If the University finds that the repair/service are not of the contract quality or not satisfactory owing to any reason, of which the University shall be the sole judge, the University shall be entitled to refuse the accept any claim.
6. If any vendor charge GST, in addition to his quoted rates this fact should be stated specifically in the quotation. In the absence of such statement the rate quoted will be deemed to be inclusive of GST. Payment of a Tax Invoice is dependent of checking of regularity of GST returns of a vendor, as applicable.
7. In case of spares, the supply is to be done through a challan only and are to be stamped at the Gate.
8. For all vendors, Professional Tax registration & annual Payment Certificate is a must.
9. Non-Compliance of an order force us not to issue any enquiry in future.
10. Up to 10% of bill value may be deducted for default and/or delay in delivery of spares and completion of service @1% per week of delay, without prior confirmation from the University.
